EXECUTIVE SUMMARY

There are both positive and negative findings in this latest ESOMAR/WAPOR study on the Freedom to Conduct and Publish Opinion Polls, the largest and most global of this series of studies, which began in 1984. The new study has more respondents, more question topics, and more information than ever before about the status of polling in the world. WAPOR and ESOMAR will supplement this report with additional information provided on each organization's website.

Methods of polling are changing. In 2017, relatively few countries were using online polling as a research method. Now, more than threequarters do (with a high of 92% in Europe, where it has replaced telephones as the dominant polling mode). In-person interviewing has remained a dominant method everywhere but Europe. Telephones - landline, mobile, or in combination - have declined from 46% in 2017 to 35% today as the dominant mode of interviewing.

The positives:

· There is more awareness and understanding of international codes and guidelines. For some guidelines, awareness has doubled from what it was in 2017. But conformity with the codes is still lacking among many pollsters.

- · Evaluations of the methodological quality of published opinion polling are generally high. In only 13% of countries is it considered of somewhat or very low quality (in Latin America and Asia Pacific Oceania one in five countries see low quality polling).
- · Technological changes have helped make polling easier, and the COVID-19 pandemic brought some positive benefits to polling, along with the expected negatives.
- · Professional associations that can address complaints about polls exist in only 30% of countries. While that is up from 24% in 2017, it is still smaller than the number of countries where a government body regulates polling.

Among the negatives:

- · Although the share of countries with limits on the publication of pre-election polls has dropped to 46%, an additional 24 countries (15%) do not permit election polling at all.
- · Governments in one-third of countries officially regulate polls.
- · More than one in four countries have taboos on publishing surveys about religion, and one in five reject polling on crime and on voting.
- · Many countries do not have access to incountry training in survey research.
- · In 43% of the 157 countries, the quality of reporting about polls in the news media is

rated as somewhat or very low quality, nearly twice as high as the share of countries who see local journalistic reporting as of somewhat or very high quality.

· Polling itself has become more difficult due to budget cuts, increased costs of data collection, and lowered response rates.

Regions like Latin America stand out as different in many areas. Latin America has the highest share of countries with pre-election poll embargoes. Nearly all countries report embargoes, and it is the region where embargoes are the longest on average (the median embargo length is seven days, though polling is more accurate the closer to election day it is conducted). In addition, more than any other region, Latin American countries report that personal interviewing is not safe. Nearly half of countries there (47%) believe that interviewers conducting face-to-face surveys are either somewhat or very unsafe, almost three times the global percentage.

Europe is the region with the second largest percentage of embargoes (behind Latin America), but for half of those countries, the restrictions on

publication last only two or three days. European countries, as well as those in Sub-Saharan Africa and North America & the Caribbean, are also the most likely to have professional associations to deal with complaints about polling and to promulgate standards.

While it appears from the tables that parts of Asia Pacific Oceania and Sub-Saharan Africa might not have pre-election restrictions on the publication of polls, in nearly a third of those countries in West Asia & North Africa and Sub-Saharan Africa, it is not permitted to publish polls about elections and voting (in about a quarter of countries in those two regions, polls about voting cannot even be conducted).

ESOMAR and WAPOR plan to use these results to publicize issues about polling regulations and the value of self-regulation. Polls provide a voice for the public and are an important means of letting both leaders and the public themselves understand what people want and need.

- Date of survey: 7-19/9/2023
- Survey method: Random telephone survey conducted by real interviewers
- Target population: Cantonese-speaking Hong Kong residents aged 18 or above
- Sample size: 1,001 (including 504 landline and 497 mobile samples)
- Effective response rate: 53.0%
- Sampling error: Sampling error of percentages not more than $\pm -5\%$, that of net values not more than $\pm -8\%$ and that of ratings not more than ± -2.0 at 95% conf. level
- Weighting method: Rim-weighted according to figures provided by the Census and Statistics Department. The gender-age distribution of the Hong Kong population came from "Mid-year population for 2022", while the educational attainment (highest level attended) distribution and economic activity status distribution came from "Women and Men in Hong Kong Key Statistics (2022 Edition)".

Our survey shows that the latest popularity rating of CE John Lee stands at 52.6 marks, which did not change much over the month past. Among all respondents, 13% gave him 0 mark. The latest approval rate of CE is 55%, disapproval rate 31%, giving a net popularity of positive 24 percentage points, which stays practically the same as last month.

Revision of the hypothetical voting of CE question




- •Starting from July 2023, the question on the hypothetical voting of the CE has been changed from "If a general election of the Chief Executive were to be held tomorrow, and you had the right to vote, would you vote for John Lee?" to "If you had the right to decide whether to reappoint or dismiss John Lee as the Chief Executive now, how would you decide?", to reflect the current development of Hong Kong.
- The answer choices have also been changed from "yes" and "no" to "reappoint", "dismiss" and "abstain", while the "don't know/hard to say" and "refusal" choices will be kept in use.


• As for the SAR Government, its latest satisfaction rate is 44%, whereas dissatisfaction rate stands at 38%, thus the net satisfaction is positive 7 percentage points. The mean score is 3.0, meaning close to "half-half" in general. These figures have not changed much compared to a month ago.

Our survey shows that the latest support rating of CS Eric Chan is 47.1 marks. His approval rate stands at 48%, disapproval rate 30%, giving a net popularity of positive 18 percentage points. Both his approval and disapproval rate have shown significant increase compared to three months ago.

Revision of the hypothetical voting of principal officials questions



- Starting from September 2023, the question on hypothetical voting on principal officials has been revised from "If you had the right to vote on the reappointment or dismissal of XXX as XXX tomorrow, how would you vote? You could also abstain from voting." to "If you had the right to decide whether to reappoint or dismiss XXX as XXX now, how would you decide?"
- As for the answer options, apart from the existing "reappoint", "dismiss", "abstain" and "refuse to answer", a "don't know / hard to say" option has been added.
- Such a change might have affected various figures.

- O Among the 15 Directors of Bureaux, only Secretary for Education Christine Choi got a negative net approval rate. Ranked from high to low, they are Secretary for Labour and Welfare Chris Sun, Secretary for Housing Winnie Ho, Secretary for Transport and Logistics Lam Sai-hung, Secretary for the Civil Service Ingrid Yeung, Secretary for Environment and Ecology Tse Chin-wan, Secretary for Health Lo Chung-mau, Secretary for Financial Services and the Treasury Christopher Hui, Secretary for Development Bernadette Linn, Secretary for Security Chris Tang, Secretary for Commerce and Economic Development Algernon Yau, Secretary for Innovation, Technology and Industry Sun Dong, Secretary for Constitutional and Mainland Affairs Erick Tsang, Secretary for Home and Youth Affairs Alice Mak, Secretary for Culture, Sports and Tourism Kevin Yeung and Secretary for Education Christine Choi.
- O Compared to half a year ago, the net approval rates of Chris Sun, Winnie Ho, Tse Chin-wan, Bernadette Linn and Sun Dong have significantly increased.
- O As mentioned, the question wordings have been revised starting from September 2023 and such a change may have affected various figures.
